

CLP Hazard Labelling Advice for Consumer Products

This advice relates to labelling rules under the Classification, Labelling and Packaging of Substances and Mixtures Regulation (EC) No 1272/2008 (CLP Regulations). Although most parts of the CLP regulations are mandated, some aspects, such as precautionary information, relate to the use of the product and the intended user and therefore some interpretation is required. The interpretation applied here relates to consumer use and follow official guidance.

Please note this advice relates to use at the specified concentration in a non-hazardous base, and using containers and or packaging which do not give additional labelling requirements (such as aerosols).

PRODUCT: LAVENDER BLOOM FRAGRANCE OIL (25% IN ETHANOL/PERFUMERS ALCOHOL)

For advisory labelling purposes only, we advise that the product above can be labelled as shown:

PRODUCT IDENTIFIER: LAVENDER BLOOM FRAGRANCE OIL (25% IN ETHANOL/PERFUMERS ALCOHOL)
(Contains: Benzyl salicylate, Coumarin, Eucalyptol)

SIGNAL WORD: Danger

HAZARD STATEMENTS IF PACK SIZE IS <125ML: May cause an allergic skin reaction. Harmful to aquatic life with long lasting effects.

HAZARD STATEMENTS IF PACK SIZE IS >125ML: Highly flammable liquid and vapour. May cause an allergic skin reaction. Causes serious eye irritation. Harmful to aquatic life with long lasting effects.

PRECAUTIONARY STATEMENTS: If medical advice is needed, have product container or label at hand. Keep out of reach of children. Keep away from heat, sparks, open flames and hot surfaces. - No smoking. Keep container tightly closed. Wash hands and other contacted skin thoroughly after handling. Avoid release to the environment. Wear protective gloves/eye protection/face protection. IF ON SKIN (or hair): Remove/take off immediately all contaminated clothing. Rinse skin with water/shower. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If skin irritation or rash occurs: Get medical advice/attention. If eye irritation persists: Get medical advice/attention. Wash contaminated clothing before reuse. In case of fire: Use carbon dioxide, dry chemical, foam for extinction. Store in a well-ventilated place. Keep cool. Dispose of contents/container to approved disposal site, in accordance with local regulations.

SUPPLEMENTAL INFORMATION: Contains 1-(1,2,3,4,5,6,7,8-Octahydro-2,3,8,8-tetramethyl-2-naphthalenyl)ethanone, 2,4-Dimethyl-3-cyclohexen-1-carboxaldehyde, Eugenol, Geraniol, Linalool, Piperonal, Reaction mass of cis-1-methyl-1-(4-methylcyclohexyl) ethyl acetate and trans-1-methyl-1-(4-methylcyclohexyl) ethyl acetate and cis- 4-isopropyl-1-methylcyclohexyl acetate and trans-4-isopropyl-1-methylcyclohexyl acetate, Terpinolene, Tetrahydrolinalool, alpha-Pinene, alpha-iso-Methylionone, delta-1-(2,6,6-Trimethyl-3-cyclohexen-1-yl)-2-buten-1-one, l-Limonene. May produce an allergic reaction.
